In-person

If you choose this method, you must provide the following information in digital and printed formats using the provided MS Excel Spreadsheet along with nine dollars and ninety-five cents (\$9.95) per Subscription ordered:

Subscriber's name, Subscriber's full address, Subscriber's phone number, Subscriber's e-mail address, and the number of Subscriptions ordered.

On-line

If you choose this method, The Organization's name will be placed on the drop down menu on the Subscription page of TSM's website, and TSM will provide you with the date when your **\$10K in 30 Days Subscription Drive Challenge** starts. This is the method The Organization uses to get credit for each Subscription sold. It is your responsibility to inform your community of the **\$10K in 30 Days Subscription Drive Challenge** and direct them to our Subscription page. We suggest using flyers, an e-mail with a link, and putting a link to the TSM Subscription page on The Organization's web-site. The donations earned by you're The Organization's will be paid to The Organization thirty (30) days after the close of the **\$10K in 30 Days Subscription Drive Challenge**. After the Subscription drive closes, the donation for each subsequent Subscription sold will revert to the standard rate of seven dollars and fifty cents (\$7.50) per nineteen dollars and ninety-five cents (\$19.95) Subscription sold.
